Information that we collect automatically

Cookies

Cookies are pieces of information that we transfer to your computer's hard drive through your web browser for record-keeping purposes. We use cookies to store some information that enables us to improve your experience at our Sites in a number of ways. Cookies also help us to learn about how and when people use our Sites so that we can determine which parts of our Sites are popular and which need to be modified to be more useful. Although cookies do identify a website user's computer, cookies alone cannot personally identify a user. Your web browser only allows us to access the cookies we have already sent to your computer, not the cookies that other websites have sent. We do not and cannot use cookies to retrieve any information from your computer that we did not put there in the first place. You can adjust your web browser to refuse all new cookies, to notify you whenever you are about to receive a new cookie, or to disable cookies completely. Please note, however, that many parts of our Sites will not function properly if you do not allow cookies.

Use of the information we collect

The primary reason why we collect information from you is to provide you with the services that you request and to enhance your experience at our Sites. We also use the information that we collect to make sure that our Sites provide you with the resources you need and the level of quality you expect. For example, information about the sections of the Sites that people visit most frequently and least frequently helps us to decide which features website users find useful and which features need changes.

Also, PTN sometimes shares with third parties certain non-personal, summary information about the people who use our Sites. Protecting your personal information
